1. Introduction

This Privacy Notice relates to the data processing activities carried out through the website www.terapianatura.hu, tudomany.terapianatura.hu and tanfolyam.terapianatura.hu (hereinafter referred to as the Website) operated by the Terápia Natúra Foundation.

We reserve the right to unilaterally change this Privacy Notice. The Privacy Notice posted on the Website from time to time will always govern the processing of data by the Terápia Natúra Foundation.

2. Data Controller's name and contact details

3. Main features of data processing

The scope, purpose and legal basis of the data processed, the duration of the processing, the recipients concerned by the processing, the information on the communication of data processing declarations and the data reporting obligations are set out in Chapter 6 of this Privacy Notice.

4. Your rights as a data subject and their enforcement

As a data subject, you have the following rights in relation to the personal data processed about you:

4.1. **Right of access** - You may request information from the Data Controller about the scope of the data processed about you, and you may request access to your personal data. The right of access provides you with the opportunity to receive feedback on whether your personal data is being processed and, if so, to access and request a copy of your personal data and to request information from the Controller about the processing.

4.2. **Right to rectification, erasure and restriction of processing** - You have the right to request the rectification or erasure of your personal data and the restriction of its processing. The right of rectification gives you the possibility to request the Controller to rectify inaccurate or incomplete data. You have the right to ask the Controller to erase personal data concerning you. If you request the restriction of the processing of your personal data, the Controller may restrict the processing in accordance with your request. If you dispute the accuracy of your personal data, the period of restriction shall be for the period of time necessary to allow the Controller to verify the accuracy of the data. You may request the restriction of the use of your personal data if the processing is unlawful but you object to its erasure. You may also

make such a request where the Controller no longer needs your personal data for the purposes of processing, but you have a need to restrict processing for the establishment, exercise or defence of legal claims.

- 4.3. **Right of objection** - You have the right to object to the processing of your personal data at any time on grounds relating to your particular situation, in the cases provided for by law.
- 4.4. **Right to data portability** - You also have the right to carry data with you under the right to data portability. You have the right under data portability to receive your personal data processed by the Data Controller in a structured, commonly used, machine-readable format and the right to have those data transferred to another controller without Data Controller preventing this. Where technically feasible, you may also request that the Controller transfer your personal data directly to another controller.
- 4.5. **Right to withdraw your consent** - You have the right to withdraw your consent to the processing of your data (for the data processed on the basis of your consent) at any time, free of charge. The withdrawal of consent does not affect the lawfulness of the processing based on consent prior to its withdrawal.

If you wish to exercise any of the above rights or if you have any questions regarding these rights or the processing of your personal data, please contact Terápia Natúra Foundation by post (please write "data protection request" on the envelope) or by email using the contact details provided in section 2 of this Privacy Notice.

5. Right to lodge a complaint, Access to justice

5.1. If you become aware that your rights are being infringed or that unlawful processing is taking place, you have the following options:

- 5.1.1. you can contact Terápia Natúra Foundation directly by post or by email using the contact details set out in section 2. *[Please write "Data Protection Request" on the envelope]*
- 5.1.2. you may take legal action against unlawful processing of your data and breaches of data security. You may be entitled to compensation and damages as provided by law. For information on the jurisdiction and contact details of the court, please visit the following website: www.birosagok.hu
- 5.1.3. if you consider that the processing of your personal data infringes the provisions of the applicable data protection legislation, in particular the GDPR, you have the right to lodge a complaint with the National Authority for Data Protection and Freedom of Information. 6.1. Webshop-related data processing
